(4) Once you successfully login, go to "Domains Pending Verification", select YCEC.SG domain, checked the box and click on "Verify Identity". (May refer to Attachment 4).

Exabytes no longer able to manage your domain YCEC.SG should there is no verification performed by March 13, 2023. You may look for other domain provider and we may provide you with the domain authorization code in order to perform the domain transfer away.
